### Statewide Ballot Propositions:

<b>Ballot Propositions:</b>	<b><u>Craig's Recommendation</u></b>
Prop. 14 - \$5 Billion in bonds for embryonic stem cell research - <b>NO</b>	<b>No – morally repugnant and there is no proof that the earlier 2002 bonds (\$3 billion) generated any good for society. And we do not need more bond debt in California.</b>
Prop. 15 – Partial repeal of Prop. 13 on property taxes – so called “Split Roll” - <b>NO</b>	This is a direct attack on Prop. 13 (the one from 1978). If it passes almost all commercial and retail properties would lose Prop. 13 protections and be re-assessed at fair market value. Building owners (Landlords) would raise the rent on retail and commercial tenants thus the cost of goods would go way up. All as businesses are trying to recover from the COVID-19 lockdowns. Guess who wants this: the California Teachers Association. The CTA already got us via Prop. 30 and 52 the highest state income taxes in the nation. No new taxes!!!! Vote <b>NO</b>
Prop. 16 – Repeal of Prop. 209. The return of racial discrimination. - <b>NO</b>	If passed this would repeal Prop. 209. Prop. 209 prohibits discrimination on things like admissions into colleges, jobs with the government and other arenas based on race, creed, color, etc. This is crazy – so now the majority party in Sacramento wants to allow discrimination in who can be admitted to colleges, jobs, etc.?!?! Prop. 209 means people get admitted / hired <i>based on merit</i> not how many of a certain race or color or ???. Prop. 16 is a big <b>NO!</b>
Prop. 17 – Allow felons on parole the right to vote - <b>NO</b>	This would return the right to vote to convicted felons who are out on parole. People on parole have not yet “paid their debt to society” otherwise there would be no need to have a parole system. They should complete their “sentence” then have the right to vote restored. Vote <b>NO</b>
Prop. 18 – Grants 17 year olds the right to vote in primary elections if they are 18 when the general election is taken. <b>NO</b>	There is a reason 17 year olds do not vote, do not have a lot of rights, etc. Maturity. A lot of 18 year olds lack maturity but lowering the voting age is a step backwards. Vote <b>NO</b>
Prop. 19 – Changes to Prop. 13 - <b>NO</b>	Changes the way property taxes on your home are transferred when you move if you are over a certain age. But there are some poison pills in the proposition that would cost families that lose a loved one or a family farm by having the home / farm <i>re-assessed at fair market value</i> . The only reason the people behind this want this is to encourage more home sales and <i>more taxes to the government</i> . Vote <b>NO</b>
Prop. 20 – Reducing crime - <b>YES</b>	This would reverse some serious weaknesses in prior years’ Prop. 47. It would require no parole for certain violent offenders; allow more arrests for shoplifting (current severely curtailed by Prop. 47 tying law enforcement’s hands) and other common sense reforms. This is a big <b>YES</b> vote.

Prop. 21 – Imposition of rent control - <b>NO</b>	Rent Control is always a bad idea and usually results in not helping most renters. This is a complicated proposition that would be difficult for property owners to follow. These types of laws usually create more housing shortages. Vote <b>NO</b>
Prop. 22 – Allow App Based Drivers (Uber, Lyft, etc.) to operate - <b>YES</b>	Last year the legislature (under pressure from unions) passed AB5 which SEVERELY restricted the right of people to work as an independent contractor rather than as an employee. The result is many, many independent workers lost their jobs. Uber and Lyft are likely going to cease operations in California if this continues. AB5 is the legislature picking winners and losers to benefit union employees. Prop. 22 allows the voters to set this right. A big <b>YES!</b>
Prop. 23 – Imposes State Regulations on Dialysis Clinics - <b>NO</b>	Another attempt to enrich unions at the expense of those getting dialysis treatment (and raising health care costs again!). Plus this would create yet another state government agency. Vote <b>NO</b>
Prop. 24 – More complicated privacy laws for businesses - <b>NO</b>	A complicated set of rules on privacy rights in California that will apply to most small businesses who can't afford to hire law firms to help them navigate it all. A win for lawyers but not small businesses trying to recover from the COVID-19 lockdowns. Vote <b>NO</b>
Prop. 25 – <b>Referendum</b> to repeal a 2018 law that replaced the cash bail system - <b>NO</b>	This is a referendum proposition = this means to agree to repeal the 2018 law you need to vote <b>NO</b> (not yes which is a vote to keep the 2018 law). No cash bail allows repeat criminal offenders to be immediately released from jail to go commit more crimes. Vote <b>NO</b>

**Municipal Ballot Measures:**

Measure BB – City of San Clemente Term Limits - <b>Yes</b>	<b>Yes</b> – Will limit someone to two four year terms then they can run again in two or more years to serve again. I would have preferred three four year terms but this is a good compromise.
